PART 14

Section 1: Method Statements

1. The Method Statements set out the methods by which Project Co will deliver the Services during the Patient Service Period. For the avoidance of doubt, the Method Statements will not apply during the Transition Period.

2. The following table sets out the agreed amendments to the Method Statements set out in this Section 2 of Part 14 of the Agreement. The parties intend to reissue the Method Statements after Financial Close to incorporate these agreed amendments. To the extent that such reissued Method Statements incorporate these amendments, the parties agree that:

(a) Project Co will not be required to submit such revised Method Statements for review under Part 10 of the Schedule (*Review Procedure*); and

(b) the provisions of Part 22 of the Schedule (*Variations*) shall not apply to such amendments (and there should be no adjustment to the Annual Service Payment as a consequence); and

(c) such documents as amended, shall then be the Method Statements for the purposes of this Agreement.
