Introduction

Falkirk Community Planning Partnership is committed to making Falkirk a fairer and more equal place to live. Our commitment to mitigating the impact of poverty on individuals, families and communities in our area is detailed in **'Towards a Fairer Falkirk 2019-2024'** and our **Integrated Children's Services Plan 2017-2020**.

Falkirk Community Planning Partnership's Fairer Falkirk Partnership brought a number of partners across the area together, to map related work from 2018-19, and gather information on the actions that we are taking to tackle child poverty.

In May 2019, we held a child poverty workshop with representatives from a number of organisations including:

- Falkirk Children's Commission
- One Parent Families Falkirk
- Falkirk Community Trust
- NHS Forth Valley
- Skills Development Scotland
- Falkirk Council
- Aberlour

The workshop was led by NHS Health Scotland's Organisational Lead on Child Poverty, Kerry McKenzie and the National Co-ordinator for Local Child Poverty Action Reports, Hanna McCulloch.

The aim of the workshop was to complete the Local Child Poverty Action Report Template, and begin to scope future priorities using the national key drivers. The session provided a national overview of the Child Poverty Action Report duty and then groups captured last years work already happening across the Falkirk area, and change ideas were shared to develop our future priorities for the LCPAR and other relevant plans.

The workshop, and the work of the Fairer Falkirk Groups has led to our annual LCPAR (table 1) and future priorities (table 2). The context for our planning is set out in Toward a Fairer Falkirk 2019-2024.

As the Fairer Falkirk Partnership is now established, co-ordination and reporting of this work will be more streamlined for our LCPAR 2019-20. Our aim is to continue to engage with young people and families with lived experience and ensure our plan is co-produced with these and identified priority groups. We are looking to test our ideas and identify opportunities to scale good practice across the authority.

We will continue to work across the Community Planning Partnership and Children's Commission to engage all relevant partners to take forward our priorities in 2019/20 and beyond.
