What Is Legacy Giving?

Leaving a gift in your will is a way for your generosity to last beyond your own lifetime.

You may decide to leave a specific sum of money or an item such as a painting or jewellery or you or you may wish to donate the remainder of your estate once your family and loved ones have been provided for.

Legacy Giving is the largest single source of income to UK charities and is completely free of inheritance tax.

Who Can I Leave A Legacy To?

You can request that your gift is used for a particular purpose or that it is left to Forth Valley Giving, in which case the Trustees of the Charity will ensure that it is used where it is most needed.

How Do I Arrange This?

All you have to do is consult your Solicitor. Alternatively, we can offer you free advice and assistance through the NHS Scotland Central Legal Office. Remember, even if you already have a will, you can make an amendment to it at any time.
